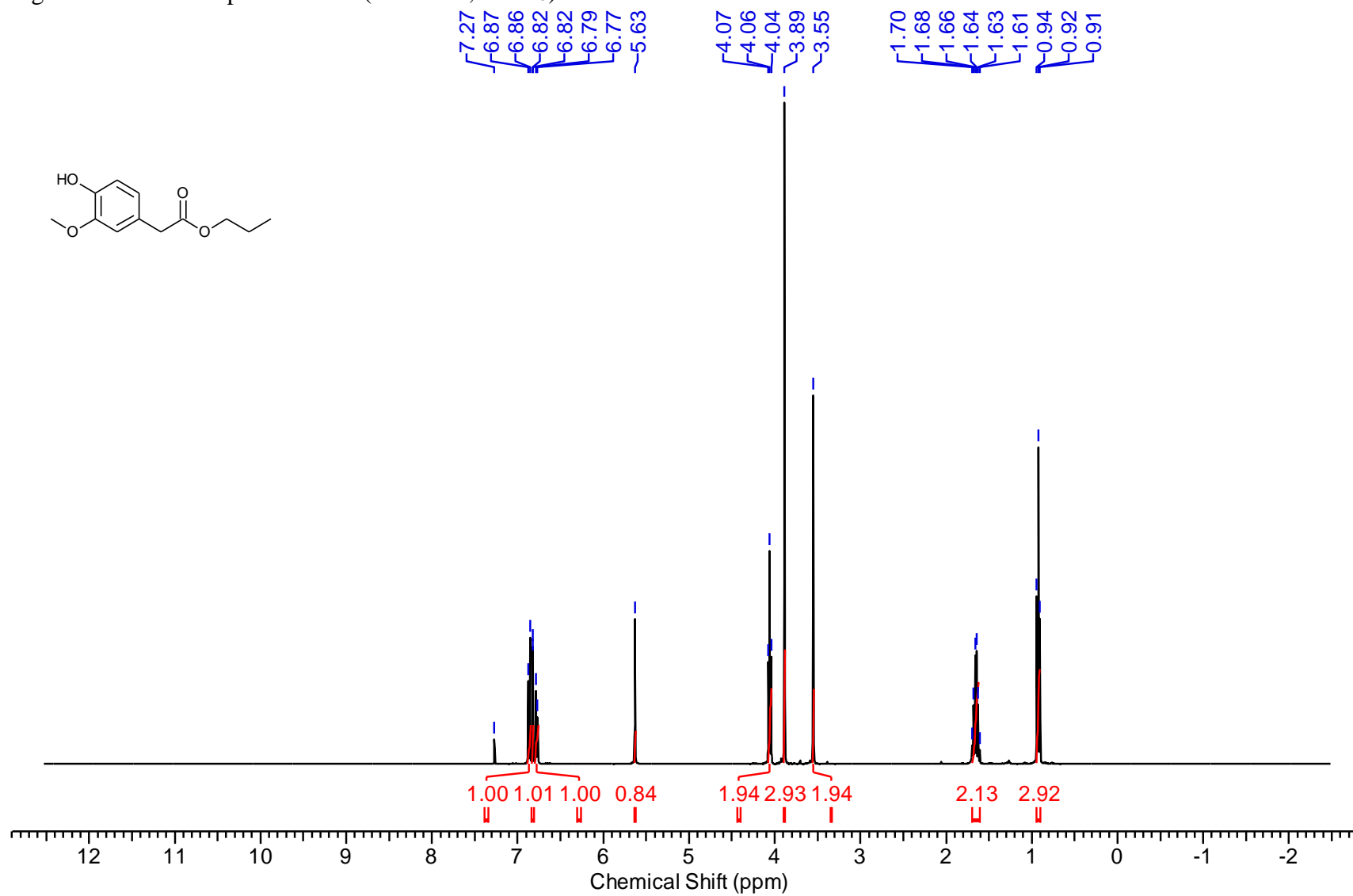


Figure S2. <sup>13</sup>C NMR spectrum of **2** (101 MHz, CDCl<sub>3</sub>).

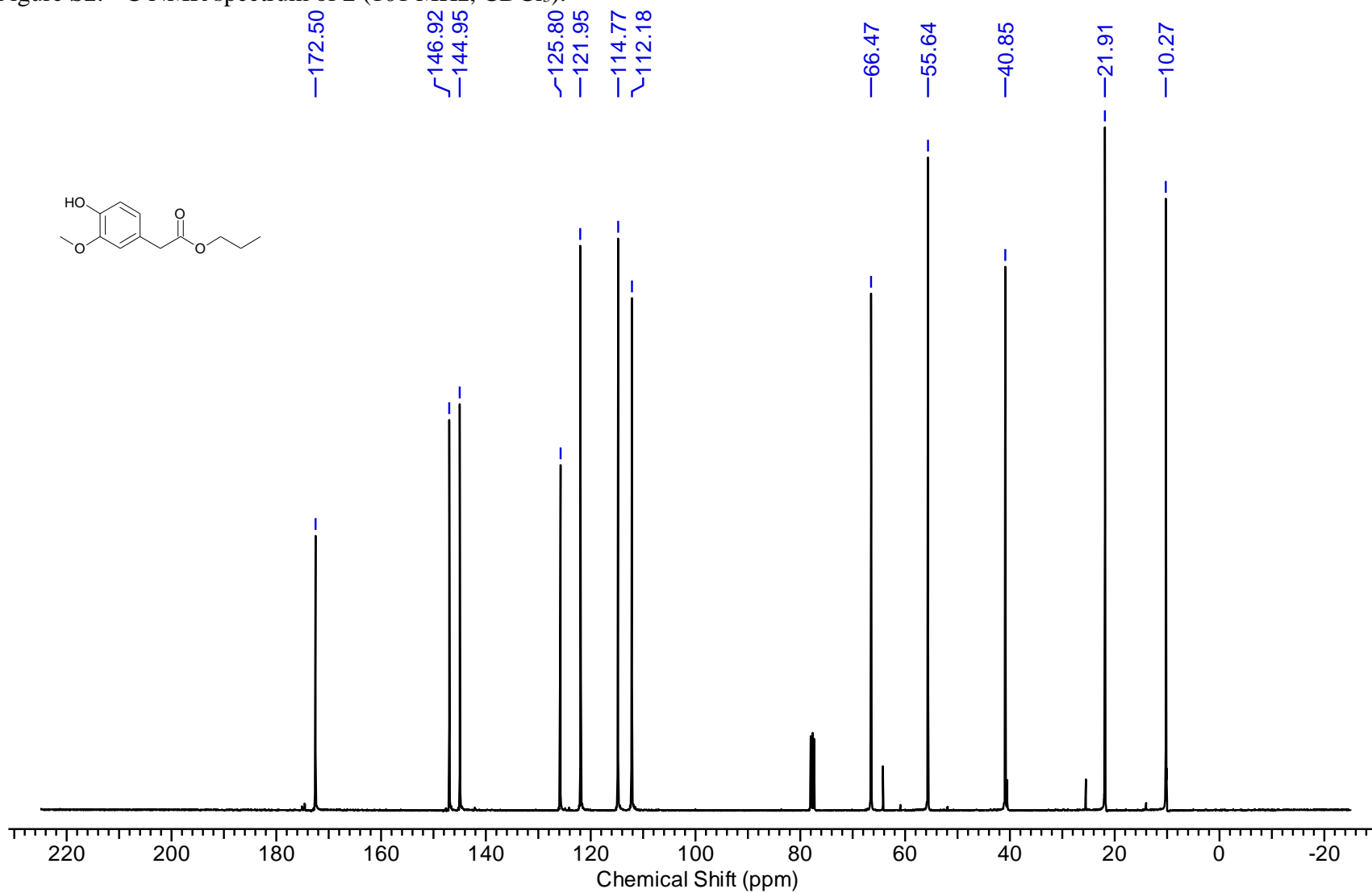


Figure S3. <sup>1</sup>H NMR spectrum of Propanidid 400 MHz, CDCl<sub>3</sub>).

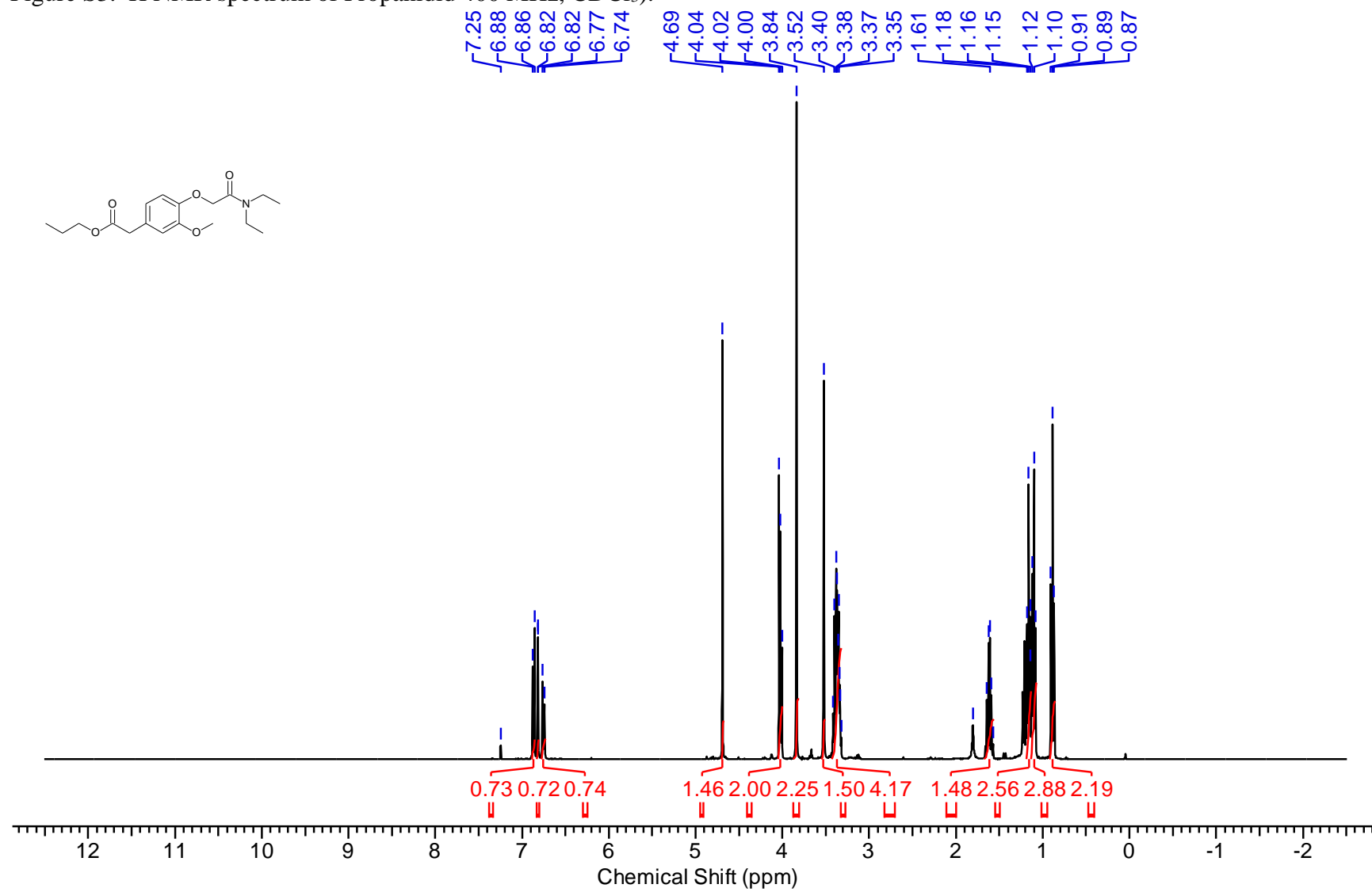


Figure S4. <sup>13</sup>C NMR spectrum of Propanidid (101 MHz, CDCl<sub>3</sub>).

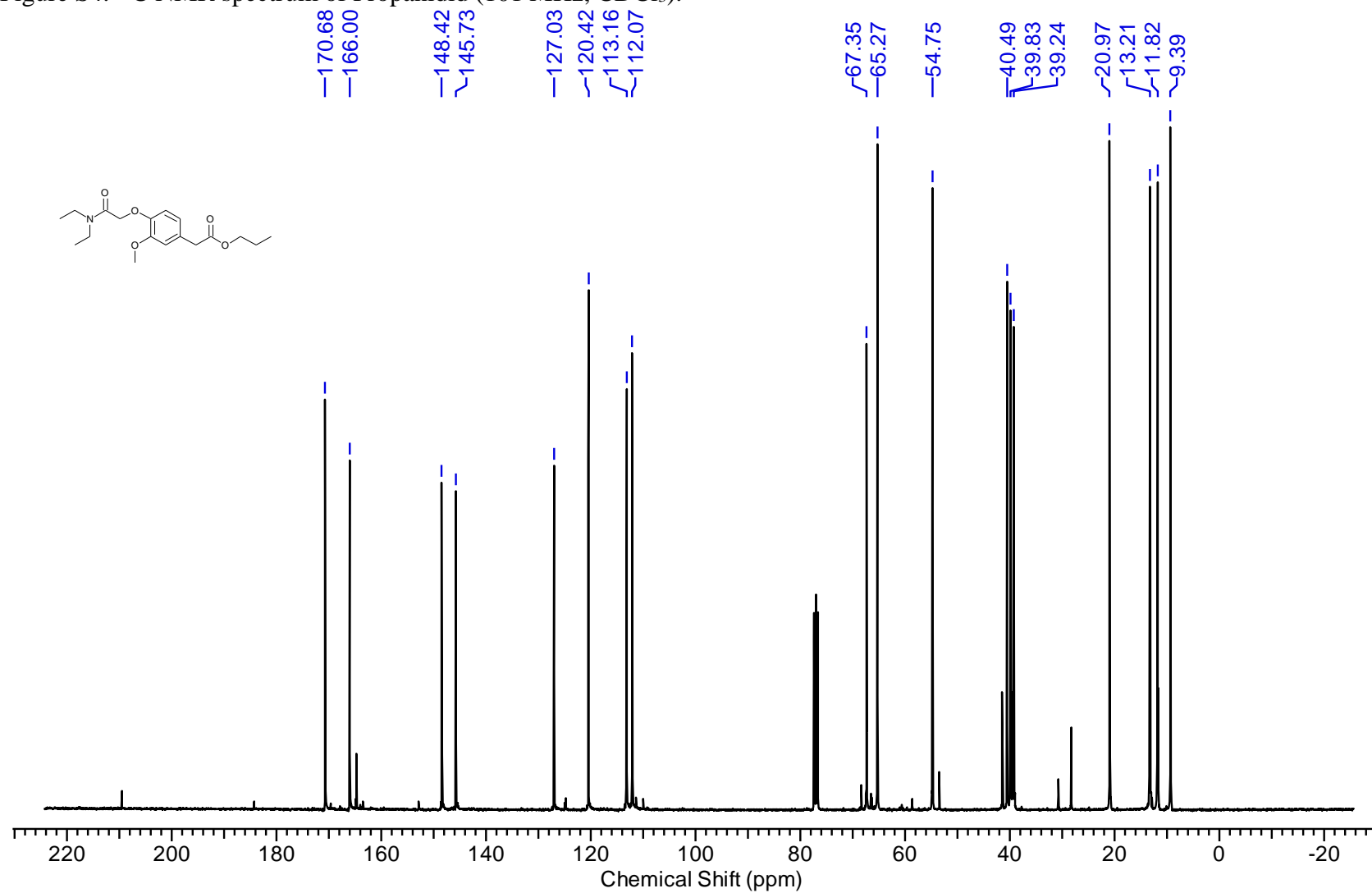


Figure S5. <sup>1</sup>H NMR spectrum of Entacapone (400 MHz, CDCl<sub>3</sub>).

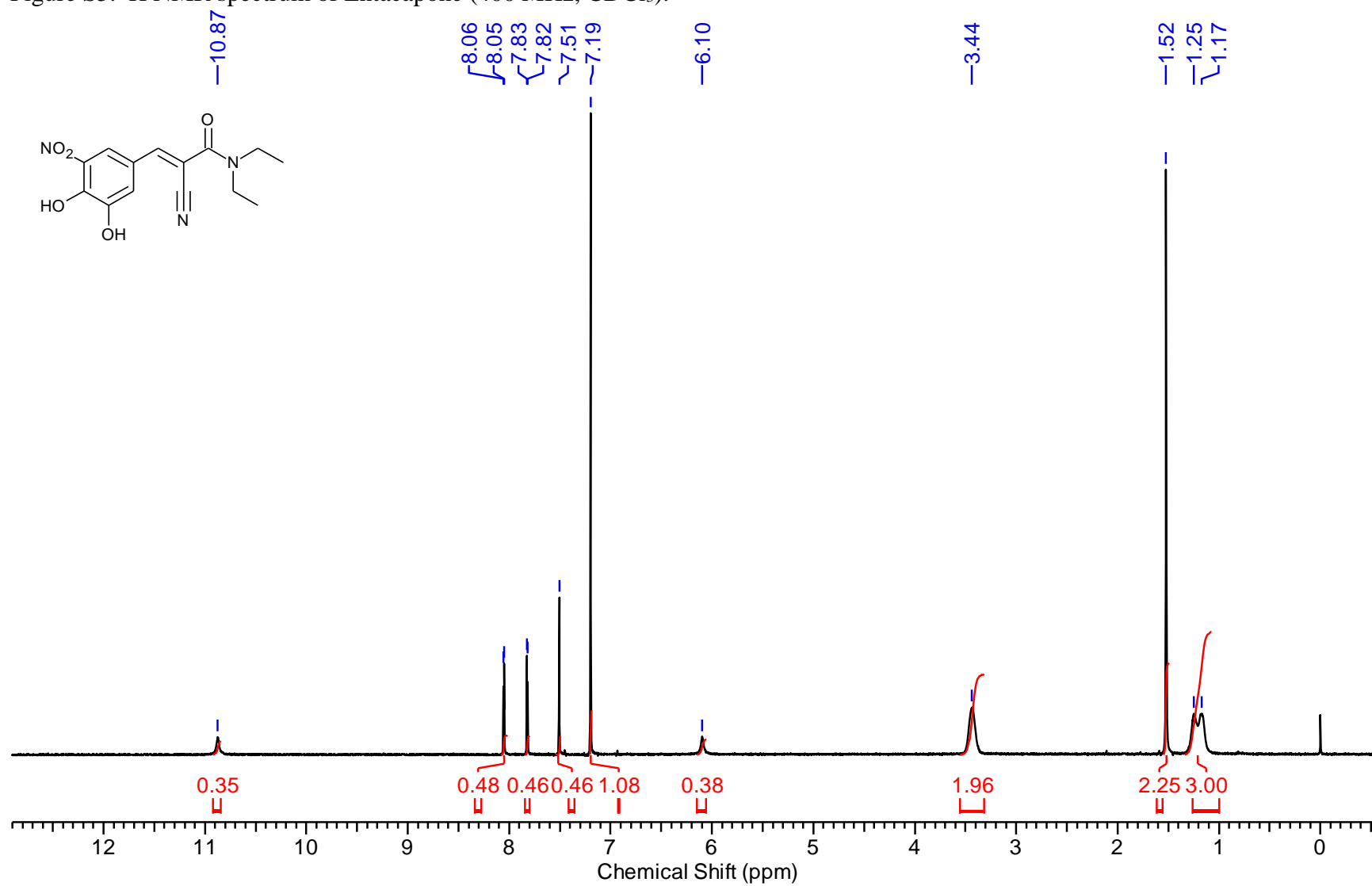
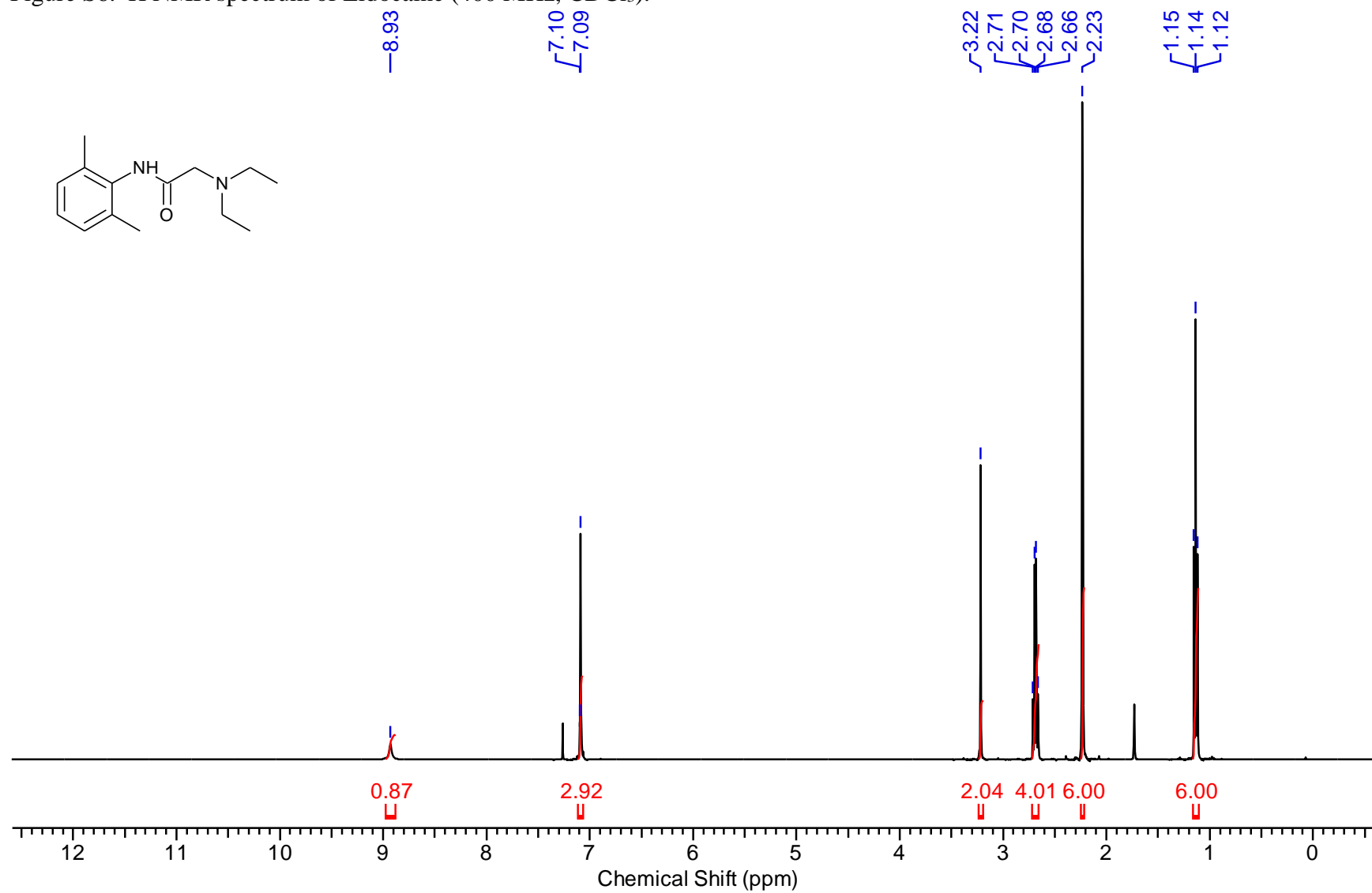


Figure S6. <sup>1</sup>H NMR spectrum of Lidocaine (400 MHz, CDCl<sub>3</sub>).
